On November 4, 1998, the State of Wisconsin Dentistry Examining Board issued a *Final Decision and Order* in the above-captioned matter. Among the terms and conditions was that the 5 year suspension period imposed was to run from November 4, 1998.

On May 5, 1999, the board considered the request of Dr. Moon that he be provided with credit under the *Order* for the time that he had been involved in the Impaired Professionals Program ("IPP"). Information provided indicated that Dr. Moon had met the requirements of IPP since December 1, 1997. Based upon the board's review and discussion, the board determined that Dr. Moon should be granted credit under the *Order* for the time he spent in IPP.

Based upon the foregoing,

IT IS HEREBY ORDERED that Craig W. Moon, D.D.S.. shall be given credit under the board's *Final Decision and Order* for the time he was involved in the IPP program. Therefore, the five (5) year suspension period ordered shall run from December 1, 1997.

FURTHERMORE, IT IS ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect.
