On March 4, 1994, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's Order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period, with provision for permitting Ms. Buchholz to petition for consecutive stays of the suspension

upon presentation of evidence that she is able to safely resume the practice of nursing.

Ms. Buchholz appeared before the board at its meeting of April 14, 1999, for the purpose of determining her eligibility to resume the practice of nursing. Ms. Buchholz and the board agreed that it will be necessary for her to complete a nursing refresher course prior to resuming practice, however Ms. Buchholz indicated that she feels she is not yet ready to undertake a refresher course at this time. Accordingly, it is ordered as follows:

NOW, THEREFORE, IT IS ORDERED that at such time as Ms. Buchholz considers herself prepared to undertake the completion of a refresher course for registered nurses, she may petition the board for a limited license which will permit her to enroll and complete the refresher course. Upon completion of the refresher course, Ms. Buchholz may petition the board for a change in the terms and conditions of the limited license so as to permit her to become employed as a registered nurse.
