ORDER RESTORING FULL LICENSURE

---

On June 20, 1997, Linda M. Humblet filed her application for a license to practice as a licensed practical nurse in the State of Wisconsin. Because Ms. Humblet indicated on her application that she had a conviction record, she was asked to appear before the board for oral interview in connection with her application. Thereafter, Ms. Humblet and the board entered into a Stipulation, by which the board agreed to grant and Ms. Humblet agreed to accept, a limited license to practice nursing in the State of Wisconsin. The board granted the license by its Order dated June 2, 1998, which required that Ms. Humblet submit work reports to the board at least until she was released from probation.

On January 29, 1999, the board considered Ms. Humblet's request that the limitations on her license be terminated. Based upon that request, and upon other information of record herein, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that all limitations of the license of Linda M. Humblet to practice as a licensed practical nurse in Wisconsin are terminated, and Ms. Humblet is hereby granted full licensure.
