On July 5, 1994, the Dentistry Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the Board's Order, Respondent's license to practice as a dentist in Wisconsin was suspended for a period of not less than five (5) years. The Order further provided that the suspension was subject to successive three-month stays provided the Respondent complied with certain conditions and limitations. Upon a showing of complete, successful, and continuous compliance for five (5) years, the Order provided that Respondent's petition for a return to full licensure would be granted.

On July 7, 1999, the State of Wisconsin Dentistry Examining Board reviewed the documentation submitted in support of the request by Thomas Richard Seidelmann, D.D.S., for a return to full licensure.

NOW, THEREFORE, IT IS HEREBY ORDERED that all limitations on the license of Thomas Richard Seidelmann, D.D.S., (#2709) to practice dentistry in the State of Wisconsin, as imposed by the Board's *Final Decision and Order* dated July 5, 1994, be, and hereby are, terminated. It is further ordered that Thomas Richard Seidelmann, D.D.S., is hereby returned to full licensure.
