MODIFICATION OF ORDER

On March 12, 1997, the State of Wisconsin Pharmacy Examining Board issued a *Final Decision and Order* in the above-captioned matter. Among the terms and conditions under the board's order was that Mr. Dallman participate in individual or group therapy sessions at least twice every month.

On August 11, 1999 the board considered a request from Mr. Dallman that he be permitted to reduce the required counseling sessions to once every month. Based upon a review of Mr. Dallman's positive record regarding his recovery, the board voted to grant his request.

Based upon the foregoing,

IT IS HEREBY ORDERED that Philip L. Dallman, R.Ph., shall participate in individual and/or group therapy sessions at least once per month.

FURTHERMORE, IT IS ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect.
