ORDER ADOPTING STIPULATION

1. On May 26, 1999, applicant filed his application for a license to practice as a professional nurse in Wisconsin by endorsement from Minnesota. Subsequent to his application, applicant notified the board that he had been disciplined by the State of Minnesota Board of Nursing, and he submitted a copy of the Minnesota disciplinary Order. The board considered the matter at its meeting of September 17, 1999, at which time applicant appeared in support of his application. The board and applicant thereafter entered into a Stipulation by which the board agreed to issue and applicant agreed to accept a limited license to practice as a registered nurse in the State of Wisconsin.

Based upon the Stipulation, IT IS HEREBY ORDERED that Kurt H. Liljequist is granted a limited license to practice as a professional nurse in Wisconsin imposing the following terms and conditions:

(a) During the period of the limited license, applicant shall comply with all terms and conditions of the Stipulation and Consent Order issued by the Minnesota Board of Nursing dated June 3, 1999, and captioned "in the Matter of Kurt H. Liljequist, R.N." A copy of the Stipulation and Consent Order is attached hereto and made a part hereof.

(b) Applicant shall be responsible for submission to the Wisconsin Board of Nursing copies of the quarterly reports required under the Minnesota Order. These include the quarterly Report from Nursing Supervisor described at section 10.c. of the Minnesota Order; the quarterly Report from Non-Nursing Employer, described at section 10.d. of the Minnesota Order; the quarterly Self-Report required by section 10.e. of the Minnesota Order; and the quarterly Report from Mental Health Professional, required by section 10.f. of the Minnesota Order.

(c) Upon removal of any of the conditions imposed by the Minnesota Order, applicant may petition the Wisconsin board for a similar reduction in the requirements under this Order. Upon removal of all limitations on applicant's Minnesota license by the Minnesota Board of nursing, applicant may apply to the Wisconsin board for a full unlimited license.

(d) A failure by applicant to meet any of the terms and conditions imposed by the June 3, 1999, Stipulation and Consent Order of the Minnesota Board of Nursing, or failure to file with the Wisconsin board the reports required hereby, shall be construed as conduct imperiling the public health, safety and welfare and may result in summary suspension of the license or imposition of additional conditions and limitations as the board may deem appropriate.

STIPULATION

It is hereby stipulated between Kurt H. Liljequist (applicant) and the State of Wisconsin Board of Nursing (board) as follows:

1. On May 26, 1999, applicant filed his application for a license to practice as a professional nurse in Wisconsin by endorsement from Minnesota. Subsequent to his application, applicant notified the board that he had been disciplined by the State of Minnesota Board of Nursing, and he submitted a copy of the Minnesota disciplinary Order.

2. The board considered the matter at its meeting of September 17, 1999, at which time applicant appeared in support of his application.

3. The board agrees to issue and applicant agrees to accept a limited license to practice as a registered nurse in the State of Wisconsin imposing the following terms and conditions:

(a) During the period of the limited license, applicant shall comply with all terms and conditions of the Stipulation and Consent Order issued by the Minnesota Board of Nursing dated June 3, 1999, and captioned "in the Matter of Kurt H. Liljequist, R.N." A copy of the Stipulation and Consent Order is attached hereto and made a part hereof.

(b) Applicant shall be responsible for submission to the Wisconsin Board of Nursing copies of the quarterly reports required under the Minnesota Order. These include the quarterly Report from Nursing Supervisor, described at section 10.c. of the Minnesota Order; the quarterly Report from Non-Nursing Employer, described at section 10.d. of the Minnesota Order; the quarterly Self-Report, required by section 10.e. of the Minnesota Order; and the Report from Mental Health Professional, required by section 10.f. of the Minnesota Order.

(c) Upon removal of any of the conditions imposed by the Minnesota Order, applicant may petition the Wisconsin board for a similar reduction in the requirements under the Order of the Wisconsin board adopting the terms of this Stipulation. Upon removal of all limitations on applicant's Minnesota license by the Minnesota Board of nursing, applicant may apply to the Wisconsin board for a full unlimited license.

(d) A failure by applicant to meet any of the terms and conditions imposed by the June 3, 1999, Stipulation and Consent Order of the Minnesota Board of Nursing, or failure to file with the Wisconsin board the reports required hereby, shall be construed as conduct imperiling the public health, safety and welfare and may result in summary suspension of the license or imposition of additional conditions and limitations as the board may deem appropriate.
