On September 6, 1995, the Wisconsin Dentistry Examining Board issued a *Final Decision and Order* in the above-captioned matter. Among other things, the decision ordered that Dr. Gragg participate in therapy sessions and a program of providing drug screens. Pursuant to a *Modification of Order (July, 1996)*, Dr. Gragg's required therapy sessions were reduced to once a month, and his drug

At its meeting on November 3, 1999, the board reviewed the written request of Dr. Gragg that the therapy and drug screen requirements be removed from his order. The board also reviewed additional information received in support of Dr. Gragg's request.

The board voted to eliminate the therapy requirement. However, the board determined that the drug screen requirement should remain as ordered since drug screens present the primary objective means by which the board can determine that Mr. Gragg is complying with the terms of his order.

Based upon the information received,

screens to twice a month.

IT IS HEREBY ORDERED that the requirement for Dr. Jerry D. Gragg to participate in therapy sessions is eliminated.

FURTHERMORE, IT IS ORDERED, that Dr. Jerry D. Gragg shall continue to participate in a program of random, witnessed collection of urine and/or blood specimens for monitoring for the presence of all controlled substances and alcohol in his blood and/or urine on a frequency of not less than two (2) times every month.

FURTHERMORE, IT IS ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect.
