ORDER MODIFYING THE LIMITED LICENSE

On March 21, 1990, the Medical Examining Board filed its Memorandum and Order on Settlement Conference in the above-captioned matter. By the terms of the board's Order, Dr. Biros was to submit to a psychological assessment performed by John C. Gonsiorek, Ph.D., and was required to undertake therapy on a schedule to be established by the board if recommended by Dr. Gonsiorek. On June 8, 1990, the board entered its Supplementary Order by which, based on Dr. Gonsiorek's recommendation, Dr. Biros was required to undertake regular psychotherapy by a psychiatrist or psychologist satisfactory to the board on a schedule as determined by the therapist, and to provide for submission of quarterly reports prepared by the therapist setting forth Dr. Biros' progress in therapy.

By letter dated September 10, 1992, Norman P. Anderson, M.D., Dr. Biros' psychotherapist, notified the board that he had recommended to Dr. Biros that regular therapy be terminated, and that Dr. Biros contact him at the end of six months and again at the end of one year for update and assessment. By letter dated September 29, 1992, Dr. Biros requested guidance from the board as to further therapy requirements.

Based on Dr. Anderson's recommendation, and other information of record herein, the board modifies its Supplementary Order of June 8, 1990, to read as follows:

NOW, THEREFORE, IT IS ORDERED that Dr. Biros submit to reassessment by Dr. Norman P. Anderson, M.D., not later than six months and again not later than one year from the date hereof. Dr. Biros shall be responsible for provision to the board of reports prepared by Dr. Anderson setting forth the results of those reassessments.

IT IS FURTHER ORDERED that all other requirements of the board's March 21, 1990, Order shall remain in full force and effect.
