ORDER REINSTATING
STAY OF SUSPENSION

To: Ronald E. Kramer, D.D.S. 6204 Kelly Place Weston, WI 54476

By a *Final Decision and Order* dated November 3, 1993, the Wisconsin Dentistry Examining Board suspended the license of Dr. Ronald E. Kramer to practice dentistry for a period of not less than five years. However, the order also provided for a stay of the suspension at three month intervals, conditioned upon Dr. Kramer's compliance with enumerated terms and conditions. A copy of the *Final Decision and Order* is attached hereto.

By an *Order Terminating Stay of Suspension and Reinstating Suspension*, dated November 4, 1998, the board suspended the dentistry license of Dr. Kramer for failing to comply with certain terms and conditions within the *Final Decision and Order*.

On January 6, 1999, the board considered information indicating that Dr. Kramer had met requirements for reinstating his stayed suspension.

Based upon the information provided, the Dentistry Examining Board enters the following,

ORDER

NOW, THEREFORE, IT IS ORDERED, that a STAY OF SUSPENSION IS GRANTED, conditioned upon compliance with all of the terms, conditions and limitations contained with the *Final Decision and Order* dated November 3, 1993, a copy of which is attached hereto and incorporated herein.

IT IS FURTHER ORDERED that the submission of the next quarterly reports and petition for extension of stay of suspension are due on May 1, 1999.
