ORDER GRANTING FULL LICENSURE

Pursuant to a Stipulation submitted by the parties, the Veterinary Examining Board issued its Final Decision and Order in this matter on December 6, 1995. By the terms of the board's Order, Dr. Beverly was required within six months of the date of the Order to complete an educational program preapproved by the board in treatment of post-casting complications in horses.

On December 9, 1998, the board considered evidence of Dr. Beverly's completion of the required program. Based on that evidence, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of J. Mark Beverly, D.V.M., to practice veterinary medicine in the State of Wisconsin are terminated, and Dr. Beverly is hereby returned to full licensure.
