On March 26, 1998, the State of Wisconsin Real Estate Board issued a *Final Decision and Order* that, among other things, ordered Ms. Anderson to pay the partial costs of the proceeding in the amount of \$1,000.00, by no later than March 26, 1999.

At its meeting of March 25, 1999, the board was advised that Ms. Anderson has paid \$200.00 toward the total costs imposed. The board also reviewed correspondence from Ms. Anderson requesting an extension of time for remitting the remainder of the costs. The request was based upon health and financial problems.

Based upon the circumstances presented and the board's review, Ms. Anderson's request was approved, as follows:

IT IS HEREBY ORDERED that the respondent, Joyce E. Anderson, is granted an extension to June 24, 1999 for paying the remainder of the costs owing in this proceeding (\$800.00) to the Department of Regulation and Licensing, P.O. Box 8935, Madison, Wisconsin 53708.
