The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. John T. Howard, D.D.S. (DOB 05/13/35) is duly licensed to practice dentistry in the state of Wisconsin (license #4001490). This license was first granted on June 27, 1959.
- 2. Dr. Howard's most recent address on file with the Wisconsin Dentistry Examining Board is 3445 Spring St., Davenport, IA 33623.
- 3. On September 25, 1995, the Iowa Board of Dental Examiners issued a Stipulation and Consent Order which imposed discipline upon the Iowa license of Dr. Howard to practice dentistry. A true and correct copy of the Statement of Charges and the Stipulation and Consent Order are attached to this document as Exhibit A. Exhibit A is incorporated into this document by reference.
- 4. On March 31, 1998, the Iowa Board of Dental Examiners issued a Stipulation and Consent Order which imposed discipline upon the Iowa license of Dr. Howard to practice dentistry. A true and correct copy of the Statement of Charges and the Stipulation and Consent Order are attached to this document as Exhibit B. Exhibit B is incorporated into this document by reference.
- 5. In resolution of this matter, Dr. Howard consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Dentistry Examining Board has jurisdiction to act in this matter, pursuant to sec. 447.07(3), Stats. and is authorized to enter into the attached Stipulation and Order, pursuant to sec. 227.44(5), Stats.
- 2. The conduct described in paragraphs 3 and 4, above, constitutes a violation of Wis. Admin. Code § DE 5.02(14).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the Dentistry Examining Board ACCEPTS the SURRENDER of the license of John T. Howard, D.D.S. (license # 4001490) to practice dentistry in the state of Wisconsin.

IT IS FURTHER ORDERED that should Dr. Howard reapply for Wisconsin licensure, the Board may in its sole discretion determine whether, and under what terms and conditions, this license may be reissued.

This Order shall become effective upon the date of its signing.
