The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Respondent Becky L. Gobermann (dob 12/6/64) is and was at all times relevant to the facts set forth herein a registered pharmacist licensed in the State of Wisconsin pursuant to license #12621, originally granted on 4/18/97.
- 2. Respondent was, on 5/21/98, disciplined by the Illinois Board of Pharmacy for obtaining prescription medications for her self beyond the refill authorization of the prescriber, on multiple occasions.
- 3. The discipline imposed by the Illinois Board of Pharmacy was effective 6/21/98 and consisted of: one year probation, \$500 fine, 6 hours of continuing education in pharmacy law in addition to the usual requirements for continuing education hours, immediate reports of all address and employment changes, and a limitation on her license in that she could not be a pharmacist-in-charge in Illinois (which term is equivalent to "managing pharmacist" in Wisconsin).

CONCLUSIONS OF LAW

- A. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter pursuant to §450.10, Wis. Stats. and is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.
- B. The conduct described in paragraph 2, above, violated § Phar 10.03(17), Wis. Adm. Code. Such conduct constitutes unprofessional conduct within the meaning of the Code and statutes.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is accepted.

IT IS FURTHER ORDERED, that Becky L. Gobermann, R.Ph, is REPRIMANDED for her unprofessional conduct in this matter.

IT IS FURTHER ORDERED, that the license to practice pharmacy of respondent is LIMITED in the following respects: respondent shall comply fully and in a timely manner with the terms of her Illinois probation in all respects and shall transmit the continuing education certificate to the Department Monitor. Respondent shall not be a managing pharmacist in Wisconsin until she is permitted to be a pharmacist-in-charge in Illinois.

Additionally, respondent shall not dispense any prescription drug or device to herself or any member of her household, until she has petitioned the Board for removal of this limitation, and has appeared before the Board in support of the petition. She may make such petition two years after the effective date of this order.

IT IS FURTHER ORDERED, that respondent shall pay COSTS in this matter in the amount of \$150, within 30 days of this order.

IT IS FURTHER ORDERED, that pursuant to §227.51(3), Wis. Stats., and ch. RL 6, Wis. Adm. Code, if the Board determines that there is probable cause to believe that respondent has violated any term of this Final Decision and Order, the Board may order that the license of respondent be summarily suspended pending investigation of the alleged violation.
