On January 29, 1999, the State of Wisconsin Real Estate Board issued a *Final Decision and Order* that, among other things, ordered Mr. Nelson to successfully complete the five hour Trust Accounts, Escrow, Closing Statement module set forth in section RL 25.02(2)(c), of the Wisconsin Administrative Code. This education was ordered to be completed within 6 months from the date of the *Final Decision and Order*.

At its meeting of May 27, 1999, the board was reviewed a request by Mr. Nelson for a 90 day extension of the time required to completed the education ordered.

Based upon the circumstances presented and the board's review, Mr. Nelson's request was approved, as follows:

IT IS HEREBY ORDERED that the respondent, George H. Nelson, is granted an extension to October 28, 1999 to successfully complete, and file proof of successful completion, of the five hour Trust Accounts, Escrow, Closing Statement module set for in section RL 25.02(2)(c), of the Wisconsin Administrative Code.
