The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Larisa Tarnovsky (DOB 02-02-48) of 9100 N. White Oak Ln., Apt. #230, Bayside, WI 53217, is duly licensed as a aesthetician in the state of Wisconsin (license #352). This license was first granted on July 31, 1997.
- Valentine Salon, 555 W. Brown Deer Rd., Fox Point, WI 53217, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #25795). This license was first granted on June 13, 1996.
 On exact dates unknown, but beginning at least in August 1997 and continuing on through July 30, 1997, Larisa Tarnovsky was employed at Valentine
- 3. On exact dates unknown, but beginning at least in August 1997 and continuing on through July 30, 1997, Larisa Tarnovsky was employed at Valentine Salon to provide aesthetic services to the public. At no time relevant to this action did Ms. Tarnovsky hold a valid and current Wisconsin aestheticians license.
- 4. In resolution of this matter, Ms. Tarnovsky consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in \P 3, above, Larisa Tarnovsky, violated sec. 454.04(1)(b), Stats.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Larisa Tarnovsky, shall pay to the Department of Regulation and Licensing a forfeiture of THREE HUNDRED dollars (\$300.00). Payment shall be submitted within 60 days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Larisa Tarnovsky fails to timely submit payment of the forfeiture as set forth above, the aesthetician license of Respondent (#352) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
