The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

**FINDINGS OF FACT**

1. Nail City, 4838 W. Fond du Lac Ave., Milwaukee, WI 53216, is duly licensed as a manicuring establishment in the state of Wisconsin (license #762). This license was first granted on August 30, 1996. Dung Anh Nguyen is listed with the Department of Regulation and Licensing as the owner of Nail City. As owner, Mr. Nguyen is and was at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.

2. On exact dates unknown, but at least on December 19, 1997, Nail City did not possess a disinfectant registered with the United States environmental protection agency as a tuberculocidal agent.

3. In resolution of this matter, Mr. Nguyen consents to the entry of the following Conclusions of Law and Order.

### CONCLUSIONS OF LAW

By the conduct referred to in ¶ 2, above, Dung Anh Nguyen, d/b/a Nail City, violated sec. 454.15(2)(i) and Wis. Admin. Code § 4.10.

### ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Dung Anh Nguyen, d/b/a Nail City, shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 30 days from the date of this order. Payment shall be made by ***certified check or money order***, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**IT IS FURTHER ORDERED** that in the event Respondents fail to timely submit any payment of the forfeiture as set forth above, the establishment license of Nail City (#762) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
