On June 8, 1999, the Barbering and Cosmetology Examining Board issued a Final Decision and Order. Mr. Page was ordered to pay a forfeiture of \$900.00 by September 8, 1999. According to information received by the board from department monitor Ted Nehring on December 6, 1999, Mr. Page has not paid the forfeiture. Therefore,

**IT IS ORDERED that establishment license #27710 issued to All Nations Barber Shop is suspended on the fifth working day after this order is signed.** Any operation of All Nations Barber Shop after January 1, 2000 will be considered operation without a license.

This suspension will be lifted upon payment of the required forfeiture.
