The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. James Edward Turner (DOB 09-05-52) 21 N. Franklin St. #5, Madison, WI 53703, was issued a private security permit by the Wisconsin Department of Regulation (permit #15818). This permit was first granted on July 2, 1997.
- 2. In Mr. Turner's application materials, he indicated "No" in response to the following question:

Have you ever been convicted of a misdemeanor or a felony, or driving while intoxicated (DWI), in this or any other state, **OR** are criminal charges or DWI charges currently pending against you? If YES, complete and attach Form #2252.

- 3. Subsequent to the issue of this permit, the Department received a report from the FBI, which revealed that Respondent was found guilty of Misdemeanor battery on August 7,1995 in the State of Wisconsin.
- 4. In resolution of this matter, Mr. Turner consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. By the conduct referred to in $\P\P$ 2-3, above, James Edward Turner, violated sec. 440.26(6), Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that James Edward Turner, is REPRIMANDED.

IT IS FURTHER ORDERED that within sixty (60) days from the date of this order, Mr. Turner shall pay the costs of this proceeding in the amount of TWO HUNDRED FIFTY dollars (\$250.00). Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:
