ORDER GRANTING LIMITED CERTIFICATION AS AN ACUPUNCTURIST

Paul A. Gerst, applicant, whose current address is 2174 West Hoyte Ave.St. Paul. Minnesota 55108, applied for certification as an acupuncturist in Wisconsin on or about July 16, 1998. Based on the qualifications of applicant as identified in his application, the Department of Regulation and Licensing issues the following order:

ORDER

- A. Applicant shall be, and hereby is, certified as an acupuncturist under ch. 451, Stats., subject to the limitations identified in the following paragraphs.
- B. Applicant shall comply with all of the terms of the STIPULATION AND ORDER of the Minnesota Board of Medical Practice (Minnesota Board Order) dated March 14, 1998, a copy of which is annexed hereto.
- C. Applicant's practice of acupuncture in Wisconsin shall be conditioned and restricted according to the same terms and degree as ordered in the Minnesota Board Order including, but not limited to, the following:
 - 1. If applicant practices acupuncture in Wisconsin, then, with respect to the approvals required of applicant's group setting practice in paragraph 4. a. of the Minnesota Board Order, of a supervising acupuncture practitioner or other licensed professional in paragraph 4. c., and of a professional boundaries training course in paragraph 4. e., the Wisconsin Department approves the group practice setting, supervising practitioner, and professional boundaries training approved by the Minnesota Board of Medical Practice.
 - 2. Applicant shall file a copy of any report, list or notice required by the Minnesota Board Order with the Director, Bureau of Health Service Professions, Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935 within 10 days after filing the report, list or notice with the Minnesota Board of Medical Practice.
 - 3. Applicant shall provide his employer with a copy of this order prior to commencing employment in Wisconsin.
 - 4. If applicant shall fail, neglect, or refuse to fully comply with each of the terms of this order, applicant's certificate to practice acupuncture in Wisconsin shall be suspended summarily and immediately upon written notice to applicant.
 - 5. Applicant may petition for removal of the limitations identified in this order on or after March 14, 1999.
- D. A copy of this order shall be mailed to the Minnesota Board of Medical Practice.
