PROCEDURAL HISTORY

On May 19, 1999, the Division of Enforcement (DOE), by its attorney Steven M. Gloe, filed a petition for an administrative injunction. A hearing on the petition was scheduled for June 28, 1999. A copy of the petition and a notice of hearing were personally served on Ms. Do on May 18, 1999.

Ms. Do failed to file an answer to the petition. The hearing on the petition was held as scheduled. Ms. Do did not appear. Mr. Gloe appeared on behalf of the Department of Regulation and Licensing. A Motion to Dismiss was filed by the DOE on June 28, 1999.

Based on the entire record of this case, this is the proposed decision and order of the undersigned administrative law judge.

FINDINGS OF FACT

- 1. Tim Thi Do does not hold a license to practice as a manicurist in the State of Wisconsin.
- 2. On May 18, 1999, the Department of Regulation and Licensing (Department) personally served Ms. Do with a Petition For Injunction. The Petition contains errors as to the business name and address of the establishment where Ms. Do was allegedly practicing manicuring.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Regulation and Licensing has jurisdiction in this matter pursuant to §440.21, Wis. Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that this matter is DISMISSED.

OPINION

The Department personally served a Petition For Injunction on Ms. Do on May 18, 1999. However, the Petition contained errors as to the business name and address of the establishment where Ms. Do was allegedly practicing manicuring. Consequently, the Division of Enforcement (Division) moved for an order dismissing this action without prejudice. Given the uncertainty of the information contained in the Petition, an Order of Dismissal is advisable. If deemed appropriate, another petition may be filed by the Division at a later date.
