The Wisconsin license to practice dentistry of Kirk D. Almendinger [9700 235th St. N., Forest Lake, MN 55025] expired effective September 30, 1997. Almendinger had applied for renewal of his license, but due to a tax delinquency his renewal was denied. On exact dates unknown, but between November 13, 1997 and continuing on through at least the end of August, 1998, Dr. Almendinger continued his practice as a dentist in the state of Wisconsin without current license registration. This conduct was in violation of secs. 447.03(1) and 447.07(3)(a) and (f), Stats.

Dr. Almendinger has now made an application for renewal of his license to practice dentistry.

The Board and the Applicant having entered into a Stipulation by which the Board agrees to issue and the applicant agrees to accept renewal of his Dentistry license subject to specified conditions, it is ORDERED as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Kirk D. Almendinger is granted a Dentistry license, subject to the following terms and conditions:

Applicant shall pay to the Department of Regulation and Licensing a forfeiture of two thousand dollars [\$2,000.00]. Upon receipt of the first one thousand [\$1,000] installment of the \$2,000.00 forfeiture together with receipt of all applicable renewal and late fees [\$123.00], the Board shall issue applicant's license.

Applicant shall in addition pay to the Department partial costs of the above-referenced investigation in the amount of five hundred dollars (\$500.00).

Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

Payment shall be made in two (2) installments and shall be paid no later than on the following schedule:

Payment #1:	\$1,000	Upon submission of renew al application and fees	Forfeiture
Payment #2:	\$1,500	Sixty [60] days following issuance of license renewal	Forfeiture and Costs

In the event that Respondent fails to timely submit payment as set forth above, his dental license (#2923) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.
