The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Sandra M. Brzozowski (DOB 05-18-49) W223N7855 Plainview Parkway, Sussex, WI 53089, is duly licensed as a barber and cosmetology manager in the state of Wisconsin (license #11399). This license was first granted on November 18, 1971.
- 2. Eye of the Beholder, 3946 S. Howell Ave., Milwaukee, WI 53207, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #24559). This license was first granted on September 21, 1995. Sandra M. Brzozowski is listed with the Department of Regulation and Licensing as the manager of Eye of the Beholder. As manager, Ms. Brzozowski was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
- 3. On exact dates unknown, but at least on September 21, 1995 and continuing on through at least July 15, 1997, Ms. Brzozowski allowed her managers license to be posted as the full-time manager of record at Eye of the Beholder. As appointed manager, Ms. Brzozowski did not perform her duties as the direct authority over the operations of Eye of the Beholder. Ms. Brzozowski initially intended her managers' license to be used on an interim basis to allow the owner to continue operation of the establishment. She did this in order to help in a financial crisis.

- 4. Ms. Brzozowski is no longer practicing in barbering and cosmetology.
- 5. In resolution of this matter, Ms. Brzozowski, consents to the entry of the following Conclusions of Law and Order and tenders the surrender of her license.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation and Order, pursuant to sec. 454.15(2), Stats.
- 2. By the conduct described in paragraph 3, above, Sandra M. Brzozowski, violated sec. 454.15(2)(i), Stats. and Wis. Admin. Code §§ BC 2.04 and 2.07.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that

- 1. The Barbering and Cosmetology Examining Board ACCEPTS the SURRENDER of the license of Sandra M. Brzozowski (license #11399) to practice as a barbering and cosmetology manager in the State of Wisconsin.
- 1. IT IS FURTHER ORDERED that should Ms. Brzozowski reapply for Wisconsin licensure, the Board may in its sole discretion determine whether, and under what terms and conditions, this license may be reissued.
- 1. This Order shall become effective upon the date of its signing.
