The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Magical Nail, 6414 N. 76th St., Milwaukee, WI 53223, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #815). This license was first granted on Novemer 15, 1986. Chinh Kieu Tran and Gung Do are listed with the Department of Regulation and Licensing as the owners of Magical Nail. As owners, Ms. Tran and Ms. Do were and are at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
- 2. On exact dates unknown, but at least on February 4, 1999, Magical Nail did not maintain equipment, tools and implements used by licensees in a clean, sanitary and safe condition.
- 3. In resolution of this matter, Ms. Tran and Ms. Do consent to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

By the conduct referred to in ¶ 2, above, Chinh Kieu Tran and Gung Do, d/b/a Magical Nail, violated sec. 454.15(2)(i), Stats. and Wis. Admin. Code § BC 4.01(1).

### ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Chinh Kieu Tran and Gung Do, d/b/a Magical Nail shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 30 days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Respondents fail to timely submit payment of the forfeiture as set forth above, the establishment license of Magical Nail (#815) SHALL BE SUSPENDED, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
