The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Johnny N.T. Nguyen (DOB 04-10-71), 5516 Durand Ave., Racine, WI 53406, is duly licensed as a manicurist in the state of Wisconsin (license #2312). This license was first granted on February 16, 1996.
2. Nails U Luv, 242 Westgate Mall, Madison, WI 53711, is duly licensed as a manicuring establishment in the state of Wisconsin (license #702). This license was first granted on April 17, 1996. Johnny Nguyen is listed with the Department of Regulation and Licensing as the owner of Nails U Luv. As owner, Mr. Nguyen is and was at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
3. On exact dates unknown, but at least on November 9, 1998, Nails U Luv did not dispose of manicure instruments that could not be cleaned and disinfected or sterilized after each use.
4. On exact dates unknown, but at least on November 9, 1998, Nails U Luv did not provide disposable towels in their toilet room nor did they store items in a closed cabinet.
5. In resolution of this matter, Mr. Nguyen consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶¶ 3-4, above, Johnny N.T. Nguyen, d/b/a Nails U Luv, violated sec. 454.15(2)(i) and Wis. Admin. Code §§ 3.01(5) and 4.10(2).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Johnny N.T. Nguyen, d/b/a Nails U Luv, shall pay to the Department of Regulation and Licensing a forfeiture of TWO HUNDRED dollars (\$200.00). Payment shall be submitted within 30 days from the date of this order. Payment shall be made by ***certified check or money order***, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Respondents fail to timely submit any payment of the forfeiture as set forth above, the establishment license of Nails U Luv (#702) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
