The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Glennie Pickett (DOB 03-23-38) 1963 W. Melvina St., Milwaukee, WI 53206, is duly licensed as a barber and cosmetology manager in the state of Wisconsin (license #14264). This license was first granted on May 10, 1978.
2. Glenn’s Beauty Salon, 3285 N. 27th St., Milwaukee, WI 53216 is duly licensed as a barbering and cosmetology establishment in Wisconsin (license #23781). This license was first granted on October 11, 1994. Glennie Pickett is listed with the Department of Regulation and Licensing as the owner and manager of Glenn’s Beauty Salon. As owner and manager, Ms. Pickett was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
3. On exact dates unknown, but beginning at least in February 1996 and continuing on through at least March 1997, Ms. Pickett employed Dawn Renee Riley to perform barbering and cosmetology services at Glenn’s Beauty Salon. At no time relevant to this action did Ms. Riley hold a valid and current Wisconsin barbering and cosmetology license.
4. On exact dates unknown, but at least on September 11, 1997, there was no manager present to provide supervision to the apprentices at Glenn’s Beauty Salon.

5. On exact dates unknown, but at least on September 11, 1997, Glenn's Beauty Salon was not in good repair as evidenced by missing floor tile in the restroom.

6. In resolution of this matter, Ms. Pickett consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 3-5, above, Glennie Pickett, d/b/a Glenn's Beauty Salon, violated sec. 454.15(2)(i), Stats. and Wis. Adm. Code §§ BC 2.04(1), BC 2.07 and BC 3.01.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Glennie Pickett, d/b/a Glenn's Beauty Salon shall pay to the Department of Regulation and Licensing a forfeiture of FIVE HUNDRED dollars (\$500.00). Payment shall be submitted as follows:

\$100.00 due on or before October 15, 1998;

\$100.00 due on or before November 15, 1998;

\$100.00 due on or before December 15, 1998;

\$100.00 due on or before January 15, 1998; and

\$100.00 due on or before February 15, 1998.

IT IS FURTHER ORDERED that in the event Glennie Pickett fails to timely submit payment of the forfeiture as set forth above, the establishment license of Glenn's Beauty Salon (#23781) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
