The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. On or about July 1, 1997, Richard R. Ryan submitted an application for a Private Security Permit to the Wisconsin Department of Regulation and Licensing. Mr. Ryan's last known address is 939 Grand Ave., Oshkosh, WI 54901.
- 2. In Mr. Ryan's application materials, he indicated "Yes" in response to the following question:

Have you ever been convicted of a misdemeanor or a felony, or driving while intoxicated (DWI), in this or any other state, **OR** are criminal charges or DWI charges currently pending against you? If YES, complete and attach Form #2252.

On Form #2252, Mr. Ryan provided information regarding one felony conviction.

- 3. On or about September 11, 1997, The Department of Regulation and Licensing approved Mr. Ryan's application and granted him a private security permit (#439). Mr. Ryan was eligible for licensure under the grandfather provisions of 1995 Senate Bill 597, Section 44.
- 4. Subsequent to the issue of this permit, the Department was notified that Respondent had been found guilty of two felonies. Respondent was convicted of sexual assault first degree on June 17, 1983 and felony traffic on May 17, 1984.
- 5. In resolution of this matter, Mr. Ryan consents to the entry of the following Conclusions of Law and Order.

# CONCLUSIONS OF LAW

1. The provision of false information in an application for a private security permit constitutes a violation of sec. 440.26(6), Stats.

## ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Richard R. Ryan, is REPRIMANDED.

IT IS FURTHER ORDERED that within sixty (60) days from the date of this order, Mr. Ryan shall pay the costs of this proceeding in the amount of TWO HUNDRED FIFTY dollars (\$250.00). Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:
