The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Samuel Baker, Jr., (DOB 05-11-54), 3624 N. 24th Pl., Milwaukee, WI 53206, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #23882). This license was first granted on July 6, 1990.
- 2. Christopher Paul's Hair Studio, 4811 W. Center St., Milwaukee, WI 53210, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #27058). This license was first granted on December 8, 1997. Samuel Baker, Jr. is listed with the Department of Regulation and Licensing as the manager of Christopher Paul's Hair Studio. As manager, Mr. Baker was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
- 3. On exact dates unknown, but beginning at least in November 1997 and continuing on through at least December 1997, Christopher Paul's Hair Studio was open and operating without a Wisconsin barbering and cosmetology establishment license.
- 4. On exact dates unknown, but at least in November 1997, Michael Knuckles was providing barbering and

cosmetology services at Christopher Paul's Hair Studio. At no time relevant to this action did Mr. Knuckles hold a valid and current Wisconsin barbering and cosmetology license.

- 5. On exact dates unknown, but at least in November 1997, Tymetric Dillon was providing barbering and cosmetology services at Christopher Paul's Hair Studio. At no time relevant to this action did Mr. Dillon hold a valid and current Wisconsin barbering and cosmetology license.
- 6. On exact dates unknown, but at least in November 1997, Stanley Burdine was providing barbering and cosmetology services at Christopher Paul's Hair Studio. At no time relevant to this action did Mr. Dillon hold a valid and current Wisconsin barbering and cosmetology license.
- 7. On exact dates unknown, but at least from January 1996 and continuing on through May 1996, Sam's Silk Hair Salon, 5335 W. Villard St., Milwaukee, WI 53218, was open and operating as a barbering and cosmetology establishment without a valid and current establishment license. At all times relevant to this action, Samuel Baker, Jr. was the owner and manager of Sam's Silk Hair Salon.
- 8. In resolution of this matter, Samuel Baker, Jr. consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. By the conduct referred to in $\P\P$ 3-7, above, Samuel Baker, Jr. violated secs. 454.08(2)(a) and 454.15(2)(i), Stats. and Wis. Admin. Code § BC 2.04(1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Samuel Baker, Jr., shall pay to the Department of Regulation and Licensing a forfeiture of FIVE HUNDRED dollars (\$500.00). Payment shall be submitted within 45 days from the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Samuel Baker, Jr., fails to timely submit payment of the forfeiture as set forth above, the manager license of Samuel Baker, Jr. (#23882) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
