The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Joy Kolar-Schleicher (DOB 12-16-1945), 611 N. Genesee, Merrill, WI 54452, is duly licensed as a barbering and cosmetology practitioner in the state of Wisconsin (license #53178). This license was first granted on October 5, 1987.
2. On exact dates unknown, but at least in November 1998, Joy Kolar-Schleicher provided barbering and cosmetology services at her residence located at 611 N. Genesee, Madison, Wisconsin.
3. Ms. Kolar-Schleicher's residence is not and was not at any time relevant to this action licensed as a barbering and cosmetology establishment.
4. In resolution of this matter, Ms. Kolar-Schleicher consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Joy Kolar-Schleicher, by the conduct referred to in ¶¶ 2 and 3, above, has violated sec. 454.08(1) and 454.15(2)(i), Stats. and Wis. Adm. Code § BC 2.04.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Joy Kolar-Schleicher, shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within sixty (60) days from the date of this order. *Payment shall be made by certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event that Joy Kolar-Schleicher fails to timely submit payment of the forfeiture as set forth above, the practitioner license of Respondent (#53178) SHALL BE SUSPENDED, without further notice or hearing, until Ms. Kolar-Schleicher has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
