The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Central Nail, 4924 W. North Ave., Milwaukee, WI 53208, is duly licensed as a manicuring establishment in the state of Wisconsin (license #1375). This license was first granted on January 28, 1999. Hoang Phuong Ngo is listed with the Department of Regulation and Licensing as the owner of Central Nail. As owner, Ms. Ngo was and is at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code chs. BC 2, 3 and 4.
- 2. On exact dates unknown, but at least on May 18, 1999, Tim Thi Do was employed at Central Nail to provide manicuring services to the public. At no time relevant to this action did Ms. Do hold a valid and current Wisconsin manicurist license.
- 3. In resolution of this matter, Ms. Ngo consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in ¶ 2, above, Hoang Phuong Ngo, d/b/a Central Nail, violated sec. 454.15(2)(i), Stats. and Wis. Admin. Code § BC 2.04.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Hoang Phuong Ngo, d/b/a Central Nail shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within 45 days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Hoang Phuong Ngo fails to timely submit payment of the forfeiture as set forth above, the establishment license of Central Nail (#1375) SHALL BE SUSPENDED, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
