On December 15, 1999, the Medical Examining Board issued its Order Adopting Stipulation in the above-captioned matter. By the terms of the board's Order, Ms. Olson was required within 10 months to complete no fewer than 12 hours of continuing education in the area of ethics for health care providers.

On October 18, 2000, the board considered Ms. Olson's petition to extend the deadline for completion of the required continuing education to February 1, 2001. Based upon that petition, and upon other information of record herein, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that the deadline for completion of continuing education required by the board's December 15, 1999, Final Decision and Order in this matter is hereby extended to February 1, 2001.
