On November 8, 2000, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Eric A. Schuster, R.Ph., for reinstatement of an unlimited license to practice pharmacy as provided within the board's *Final Decision and Order* dated May 14, 1996, case number 95 PHM 55.

Based upon the board's review,

IT IS HEREBY ORDERED, that the petition of Eric A. Schuster, R.Ph., for restoration of an unlimited license to practice pharmacy is denied. The petitioner has failed to submit proof satisfactory to the board that he has completed five years of practice of pharmacy in compliance with all terms and conditions of the *Final Decision and Order* dated May 14, 1996, and demonstrated that he may practice pharmacy without condition or limitation with skill and safety to patient and public.

IT IS FURTHER ORDERED, that Eric A. Schuster, R. Ph., may apply for a stay of suspension pursuant to the *Order* upon demonstrating compliance with the terms and conditions thereof.
