The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department Secretary. The Department Secretary has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department Secretary adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

- 1. Thea A. Woods, 7207 W. Greenfield Avenue, Milwaukee WI 53209, is not and was not at any time relevant to this action licensed in the state of Wisconsin to practice barbering and cosmetology. Ms. Woods is seeking an apprentice permit.
- 2. On or about December 8, 1999, Thea A. Woods was seen cutting hair at HR 2000, 6538 W. Fond Du Lac Ave., Milwaukee, Wisconsin. Ms. Woods contends that she was not working for compensation at this time.
- 3. Ms. Woods understands that she needs a license to practice barbering and cosmetology in the state of Wisconsin. In resolution of this matter, Ms. Woods consents to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Department of Regulation and Licensing has jurisdiction in this matter pursuant to sec. 440.21, Stats.
- 2. A license is required to practice barbering and cosmetology in the state of Wisconsin, pursuant to sec. 454.02(1), Stats.

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the Respondent THEA A. WOODS is ENJOINED and PROHIBITED as follows:

- 1. Respondent SHALL NOT PRACTICE OR OFFER TO PRACTICE BARBERING AND COSMETOLOGY in the state of Wisconsin unless and UNTIL she obtains a license, a temporary permit or an apprenticeship permit from the Barbering and Cosmetology Examining Board.
- 2. Violation of the above-order may result in a forfeiture of up to \$10,000.00 for each offense, and each day of a continued violation constitutes a separate offense.
- 3. This Order shall become effective upon the date of its signing.
