ORDER GRANTING FULL LICENSURE
On January 26, 2000, the Veterinary Examining board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a veterinarian in Wisconsin was limited to require that he complete at least 16 hours of continuing education in the area of general surgery.
On May 24, 2000, the board considered Dr. Wright's petition for reinstatement of an unlimited license based upon his completion of all requirements imposed by the Order. Based upon that petition, and upon all other information of record herein, the board orders as follows:

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of David A. Wright, D.V.M., to practice veterinary medicine in the State of Wisconsin are terminated, and Dr. Wright is hereby reinstated to full licensure
