ORDER DENYING STAY

Respondent

On March 30, 2000, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period, with provision for successive three-month stays of the suspension conditioned upon compliance with certain conditions and limitations on the license. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, that she participate in psychotherapy a minimum of once per week, and that she participate in program of random witnessed monitoring for controlled substances and alcohol in her blood or urine on a frequency of not less than once per week.

On September 1, Ms. Hanaman appeared before the board in support of her request for a further three month stay of the suspension of her license. The board on that date considered Ms. Hanaman's request, and considered as well evidence that on August 16, 2000, her urine screen was positive for cocaine.

Based upon respondent's request, and upon all other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Ms. Hanaman's request for a further three month stay of the suspension of her license is denied. Ms. Hanaman may make a further request for a stay to be considered by the board at its November 3, 2000, meeting, and such request shall be granted upon satisfactory evidence that Ms. Hanaman has been fully compliant with the board's March 30, 2000, Order during the previous two month period.
