The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. James William Olson (DOB 07-27-42) 43 Bellaire Ct., Appleton, WI 53233, was issued a private security permit by the Wisconsin Department of Regulation (permit #12024). This permit was first granted on September 3, 1999.

2. In Mr. Olson's application materials, he indicated "No" in response to the following question:

Have you ever been convicted of a misdemeanor or a felony, or driving while intoxicated (DWI), in this or any other state, **OR** are criminal charges or DWI charges currently pending against you? If YES, complete and attach Form #2252.

3. Subsequent to the issue of this permit, the Department received a report from the FBI, which revealed that Respondent had a history of criminal convictions.

4. In resolution of this matter, Mr. Olson consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. By the conduct referred to in ¶¶ 2-3, above, James William Olson, violated sec. 440.26(6), Stats.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that James William Olson, is **REPRIMANDED**.

IT IS FURTHER ORDERED that Mr. Olson shall pay the costs of this proceeding in the amount of ONE HUNDRED dollars (\$100.00). Payment shall be submitted as follows:

\$25.00 on or before April 15, 2000;

\$25.00 on or before June 15, 2000;

\$25.00 on or before August 15, 2000; and

\$25.00 on or before October 15, 2000.
