STAY OF SUSPENSION

On May 19, 2000, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period. The Order provided that Ms. Rabska could petition for successive three-month stays of the suspension of the license conditioned upon compliance with certain conditions and limitations on the license.

By letters dated August 16 and October 17, 2000, Ms. Rabska requested a three month stay of the suspension and that she be permitted to appear before the board in support of her request. She appeared before the board on November 3, 2000, and the board considered the matter on that date.

Based upon her request and other information of record, **IT IS HEREBY ORDERED** that the suspension of the license of Gail M. Rabska, R.N., is stayed for a period of three months. Ms. Rabska may petition for further three month stays of the suspension, which shall be granted upon satisfactory demonstration of having complied with all terms and conditions imposed by the board's May 19, 2000, Final Decision and Order during the preceding three month period.
