On May 18, 2000, the Board of Nursing issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice as a registered nurse in Wisconsin was suspended for an indefinite period, with provision for successive three-month stays of the suspension conditioned upon compliance with certain conditions and limitations on the license. Among these were that respondent participate in a recognized program for the treatment of chemical dependency, that she participate in psychotherapy a minimum of once each week, and that she participate in program of random witnessed monitoring for controlled substances and alcohol in her blood or urine on a frequency of not less once per week.

On May 19, 2000, the board considered Ms. Schuck's request for a three month stay of the suspension.

On September 1, 2000, the board considered Ms. Schuck's request for another three month stay of the suspension. Based upon respondent's request, and upon all other information of record herein, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of the license of Ann Marie Schuck, R.N., to practice professional nursing in Wisconsin is hereby stayed for a further period of three months. Ms. Schuck may petition for further three month stays, and such petitions shall be granted upon submission of satisfactory evidence that Ms. Schuck has fully complied with the board's May 18, 2000, Order during the preceding three month period.
