The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Kelly J. Dix (DOB 12/25/77), 343 Kennedy Drive, Brillion, WI 54110, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #28248). This license was first granted on April 10, 2000.
2. On exact dates unknown, but at least in January 2000, Kelly J. Dix provided barbering and cosmetology services at her residence located at 343 Kennedy Drive, Madison, Wisconsin.
3. Ms. Dix's residence is not and was not at any time relevant to this action licensed as a barbering and cosmetology establishment.
4. In resolution of this matter, Ms. Dix consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

Kelly J. Dix, by the conduct referred to in ¶¶ 2 and 3, above, has violated sec. 454.08(1)(b) and 454.15(2)(i), Stats. and Wis. Adm. Code §§ BC 2.045(1) and 3.01(1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Kelly J. Dix, shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00). Payment shall be submitted within sixty (60) days from the date of this order. *Payment shall be made by certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event that Kelly J. Dix fails to timely submit payment of the forfeiture as set forth above, the manager's license of Respondent (#28248) SHALL BE SUSPENDED, without further notice or hearing, until Ms. Dix has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
