The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Genevieve A. Martineau (D.O.B. 07/13/57) is duly licensed as a Nursing Home Administrator in the state of Wisconsin (license #2815). This license was first granted on November 21, 1995.
2. Respondent’s most recent address on file with the Wisconsin Nursing Home Administrators Examining Board is 302 East 5th Street, Superior, WI 54880.
3. At all times relevant to this action, Respondent was working at Villa Marina Health and Rehabilitation Center, Inc. [f/k/a Chaffey Nursing Home, Inc.] in Superior, Wisconsin. Respondent worked at this facility from 1983 through 1999.
4. During her term of employment at Villa Marina, Respondent diverted funds for her personal use from various sources, including but not limited to: the revolving account for resident funds; residents’ social security checks, veterans administration checks and personal checks; the dietary reimbursement fund; petty cash fund; and the facility staff "Sunshine Fund."
5. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Nursing Home Administrators Examining Board has jurisdiction over this matter, pursuant to sec. 456.10, Stats.
2. The Wisconsin Nursing Home Administrators Examining Board is authorized to enter into the attached stipulation, pursuant to sec. 227.44(5), Stats.
3. The conduct described above constitutes a basis for discipline under sec. 441.10(1)(a), Stats. and Wisconsin Administrative Code § NHA 5.02(1) and (8). Furthermore, the Findings of Fact set forth in paragraph 4 above constitute an agency finding of misappropriation within the meaning of secs. 48.685 and 50.065, Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Genevieve A. Martineau shall SURRENDER her license to practice as a Nursing Home Administrator in the state of Wisconsin (license #2815).

IT IS FURTHER ORDERED that should Ms. Martineau reapply for Wisconsin licensure, the Board may in its sole discretion determine whether, and under what terms and conditions, a license may be reissued.

This Order shall become effective upon the date of its signing.
