The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Anthony C. Walker (DOB 09-27-54) P.O. Box 847, Milwaukee, WI 53201, was issued a private security permit by the Wisconsin Department of Regulation (permit #10500). This permit was first granted on March 10, 1999.
- 2. In Mr. Walker's application materials, he indicated "No" in response to the following question:

Have you ever been convicted of a misdemeanor or a felony, or driving while intoxicated (DWI), in this or any other state, **OR** are criminal charges or DWI charges currently pending against you? If YES, complete and attach Form #2252.

- 3. Subsequent to the issue of this permit, the Department received a report from the FBI, which revealed that Respondent was found guilty of Misdemeanor Battery on September 24, 1976 in the state of Illinois
- 4. In resolution of this matter, Mr. Walker consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. By the conduct referred to in ¶¶ 2-3, above, Anthony C. Walker, violated sec. 440.26(6), Stats.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Anthony C. Walker is REPRIMANDED.

IT IS FURTHER ORDERED that Mr. Walker shall pay the costs of this proceeding in the amount of ONE HUNDRED FIFTY dollars (\$150.00). Payment shall be submitted as follows:		
\$20.00 due on or before April 15, 2000;		
\$20.00 due on or before May 15, 2000;		
\$20.00 due on or before June 15, 2000;		
\$20.00 due on or before July 15, 2000;		
\$20.00 due on or before August 15, 2000;		
\$20.00 due on or before September 15, 2000; and		
\$30.00 due on or before October 15, 2000.
