The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Paul Cooper, 2478 W. Capitol Avenue, Milwaukee, WI 53209, is listed with the Department of Regulation and Licensing as the owner of a duly licensed barbering and cosmetology establishment in the State of Wisconsin, known under the trade name, Tight Again Salon.
2. Tight Again Salon, 2478 W. Capitol Avenue, Milwaukee, WI 53209, is licensed as a barbering and cosmetology establishment in the State of Wisconsin (license #80-28150). This license was first granted on March 29, 1999.
3. As the owner of a licensed establishment, Paul Cooper, was at all times relevant to this action responsible for compliance with ch. 454, Stats. and Wisconsin Administrative Code, chs. BC 2, 3 and 4.
4. On exact dates unknown, but beginning at least on October 13, 1999 and continuing through July 7, 2000,

Cooper was employed at Tight Again Salon and provided barbering and cosmetology services to the public.

5. At no time relevant to this action did Cooper hold a valid and current Wisconsin barbering and cosmetology license or permit. Cooper had an apprentice contract for Kiss and Makeup Salon, which was cancelled on April 15, 1999. A copy of the Apprenticeship Cancellation Notice is attached and marked as State's **Exhibit 1**.

6. On exact dates unknown, but beginning at least on July 7, 2000, Eureka Johnson was employed at Tight Again Salon and provided barbering and cosmetology service to the public. At no time relevant to this action did Johnson hold a valid and current Wisconsin barbering and cosmetology license or permit.

CONCLUSIONS OF LAW

By the conduct referred to in the paragraphs above, Paul Cooper, d/b/a Tight Again Salon, has violated secs.454.04 (1) (a) and BC 2.04 (1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that Paul Cooper, d/b/a Tight Again Salon shall pay to the Department of Regulation and Licensing a forfeiture of TWO THOUSAND dollars (**\$2,000.00**). Payment shall be submitted within 60 days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to:

IT IS FURTHER ORDERED that in the event Paul Cooper fails to timely submit payment of the forfeiture as set forth above, the establishment license of Tight Again Salon (#80-28150) **SHALL BE SUSPENDED**, without further notice or hearing, until Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
