On October 11, 2000, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Gregory J. Kujawa, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* dated February 13, 1996, and a request to be allowed to work an additional (8) hours per week as a pharmacist in charge, in addition to the (24) hours currently worked as a pharmacist in charge.

Based upon the board's review,

IT IS HEREBY ORDERED that Gregory J. Kujawa, R.Ph., is granted a three-month stay of the suspension of license #9508 to practice pharmacy in the State of Wisconsin. The request for granting an additional (8) hours per week working as a pharmacist in charge is granted, for a total of (32) hours per week working as a pharmacist in charge.

FURTHERMORE, IT IS ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect.
