On December 12, 2000, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Marilyn Kuhrt for a continued three month stay of suspension as provided in the board's *Final Decision and Order* dated April 1998, and a request to terminate the requirement of counseling as provided in paragraph 2b(2) of that *Order*.

Based upon a review of the documentation submitted:

IT IS HEREBY ORDERED that a three month stay of suspension is granted. The request for the board to terminate the requirement of counseling as provided in paragraph 2b(2) of the *Order* is denied. Kuhrt may request termination of the requirement of counseling as required in paragraph 2b(2) of that *Order* upon the condition she agree that drug screening as required in paragraph 2b(4) be increased to two (2) times per week.

FURTHERMORE, IT IS ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect.
