That amount is established by affidavits as \$15,408.35. Dr. Carpenter has requested that he be allowed to pay the costs in three installments. The request is approved. Therefore,

IT IS ORDERED that Robert Carpenter, D.C. pay a total of \$15, 408.35 as reimbursed for the costs of this disciplinary proceeding to the Department of Regulation and Licensing, with payments as follow:

- a payment of \$3,852.00 by May 5, 2000, and
- a payment of \$3,852.00 by July 7, 2000.
