On November 8, 2000, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Roger G. Iverson, R.Ph., for a three-month stay of suspension, as provided within the board's *Final Decision and Order* ("Order") dated December 8, 1998. Based upon the board's review and consideration of the submitted documentation,

IT IS HEREBY ORDERED: that Roger G. Iverson, R.Ph., is denied a three-month stay of the suspension of license #8239 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERD: that Mr. Iverson may petition the board for a three month stay of suspension at the next regularly scheduled meeting of the board by submitting to the department monitor the below listed information as follows:

1. Evidence of having obtained an individual therapy counselor who shall contact the department monitor to confirm that a patient/therapist relationship has commenced.
2. Evidence of having obtained and entered group therapy counseling, such evidence to consist of the group therapy counselor contacting the department monitor to confirm that a patient/therapist relationship in the group therapy context has commenced.
3. Evidence of having obtained a location for urine donation and screening, such donation and screening to be random and to occur eight times per month, pursuant to the terms of the *Order*.
