## ORDER GRANTING FULL LICENSURE

By its Final Decision and Order dated October 21, 1998, the medical Examining Board accepted a stipulated resolution of this matter, and thereby limited Dr. Logan's license to practice medicine and surgery in Wisconsin to prohibit her from the practice of obstetrics.

By letter dated June 3, 1999, Dr. Logan petitioned to meet with the board at its June meeting to learn what conditions would need to be met in order to remove the limitation. Dr. Logan appeared before the board on June 23, 1999, and the board considered the matter on that date. the board thereafter issued its Order Establishing Conditions dated July 2, 1999, ordering that upon satisfactory completion by Dr. Logan of a course in fetal monitoring approved in advance by the board, the board would consider a further petition by Dr. Logan for a return to full licensure.

On March 23, 2000, the board considered Dr. Logan's request for approval of a course in fetal monitoring proposed by Dr. Thomas C. Meyer of the U.W. School of Medicine Continuing Medical Education. The board approved the course by its Order dated March 23, 2000.

On April 19, 2000, the board considered Dr. Logan's petition for termination of the limitation on her license, and considered as well evidence of satisfactory completion by Dr. Logan of the U.W. School of Medicine continuing education program. Dr. Logan appeared before the board in support of her petition.

Based upon Dr. Logan's petition, and upon other information of record herein, the board orders as follows:

#### <u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that all limitations on the license of Laurie A. Logan to practice medicine and surgery in the State of Wisconsin are terminated, and Dr. Logan is hereby reistated to full licensure.
