ORDER GRANTING STAY  
OF SUSPENSION

On November 1, 2000, the State of Wisconsin Dentistry Examining Board reviewed the documentation submitted in support of the request by Craig W. Moon, D.D.S., for a four-month stay of suspension, as provided in the Board's *Final Decision and Order* dated November 4, 1998.

Based upon the Board's review,

IT IS HEREBY ORDERED that Craig W. Moon, D.D.S., is granted a four-month stay of the suspension of License #4042 to practice dentistry in the State of Wisconsin.

IT IS FURTHER ORDERED:

1. Under the terms of the *Order* there shall be eight (8), random urine screens per month. Each urine donation shall be witnessed.
2. The urine donations shall occur at PRN (Professional Recovery Network) or at a location submitted to the Department monitor and approved by the Board chairperson.
3. Craig Moon shall not have possession, custody, or control of any urine sample after its donation.

Please be advised that the next submission of reports and the petition for an extension of a stay of suspension are due on February 15, 2001.
