On July 11, 2000, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by Craig W. Moon, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* dated August 12, 1998, and a request to be allowed to open and close the pharmacy one Sunday monthly.

Based upon the board's review,

IT IS HEREBY ORDERED that Craig W. Moon, R.Ph., is granted a three-month stay of the suspension of license #10536 to practice pharmacy in the State of Wisconsin, and is permitted to open and close the pharmacy not more than once every fourth (4) Sunday. The total hours worked as pharmacist in charge shall remain at sixteen (16).

FURTHERMORE, IT IS ORDERED that in all other respects, the previous orders of the board in this matter remain in full force and effect.
