ORDER GRANTING THE STAY

On January 20, 1999, the Medical Examining Board issued its Final Decision and Order in the above-captioned matter. By the terms of the board's order, respondent's license to practice medicine and surgery in Wisconsin was suspended for a period of not less than five years, with provision for consecutive three month stays of the suspension contingent upon compliance with a number of conditions and limitations on the license. Among other conditions, Dr. Darcy was required to enroll and successfully participate in a drug and alcohol treatment program satisfactory to the board, including participation in individual or group therapy on at least a weekly basis; to participate in AA or NA meetings at least once per week; to submit to drug and alcohol screens on a twice-weekly basis; and to be responsible for submission of quarterly practice and therapy reports.

On March 23, 2000, the board considered Dr. Darcy's request for a further three month stay of the suspension, and his further request that his mentor be changed from Dr. Robert Merrill to Dr. Elwyn Mantei. Based upon evidence of Dr. Darcy's compliance with the terms and limitations on his license, the board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of the license of David D. Darcy, M.D., to practice medicine and surgery is hereby stayed for a further period of three months, conditioned upon his compliance with the board's reporting requirements within seven days of the day hereof. Dr. Darcy may petition for further stays of the suspension upon demonstrating his compliance with all terms and conditions of the license during the preceding three month period.

IT IS FURTHER ORDERED that the board hereby approves Elwyn C. Mantei, M.D., as Dr. Darcy's professional mentor.
