ORDER GRANTING STAY OF SUSPENSION (APRIL, 2000)

On April 11, 2000, the State of Wisconsin Pharmacy Examining Board reviewed the documentation and testimony submitted in support of the request by Cory S. Ford, R.Ph., for a modification of the board's *Final Decision and Order* dated March 10, 1999, to permit work as an on-call pharmacist in charge.

Based upon the board's review,

IT IS HEREBY ORDERED that Cory S. Ford, R.Ph., is permitted to work as an on-call pharmacist in charge upon the following conditions:

1. The respondent work no more frequently than every fourth weekend as an on-call pharmacist.

2. The respondent's employer shall prepare complete quarterly controlled substances audits.

3. The respondent's employer shall have on-call a pharmacist backup in attendance for the purpose of schedule II controlled substances dispensing or handling. Otherwise, the respondent is to have no control of or charge over schedule II controlled substances during his on-call hours.

4. The respondent's employer shall utilize a security system that at all times monitors the respondent's entry and exit at the pharmacy during his on-call hours.

In all respects, all other orders of the board remain in full force and effect.
